Define: Clearly define the problem based on the insights from the empathize stage.


Ideate: Generate possible solutions or improvements.


State Pharmacy Council's Professional Development Cycle





Council Review


The council evaluates your application.

Receive your license to practice pharmacy.



Begin your career as a licensed pharmacist.







Explains the authority and influence of the councils in enforcing regulations.





Advising the State Government

Providing advice on pharmacy practice and pharmaceutical policy.

Promoting Ethical Practices

Developing codes of ethics and taking action against unethical practices.



Registration of Pharmacists


Maintaining a register of qualified pharmacists eligible to practice in the state.

How to resolve conflicts between state and federal pharmacy laws?

Seek Legal Advice

State Law Prevails

State law may be upheld if it provides stricter regulations or protections that do not contradict federal law.

Federal Law Prevails

In cases of direct conflict, federal law typically takes precedence over state law due to the Supremacy Clause of the U.S. Constitution.

Promotes adherence to ethical standards to maintain integrity in pharmacy practice.




Violation Framework
